- 2) In response to the growing number of attacks on WordPress websites, IQS will be offering web hosting services for WordPress websites only on <u>dedicated individual cloud server environments</u> that have advanced security systems specifically designed for WordPress software, automated backup systems, and downtime monitoring. This server environment is a large upgrade from the shared server environment IQS offered over the years, and existing clients who have WordPress websites will need to decide on one of the two new plans below before June 1st, 2021 which is when we will discontinue future use of the shared server for WordPress.
- 3) Payment for Services
- Amount Owing from Client. In exchange for the Services provided by IQS, the Client agrees to pay IQS a total based on selected plan. Client's payment is due upon receipt. IQS will invoice Client for payment, however amounts due from Client under this Agreement shall be due and owing even in the absence of any invoice. Further, subject to the Termination provisions at Section 4 and the Limitation of Liability provisions at Section 6 of this Agreement, Client agrees that the entire payment is due and owing upon execution of this Agreement and commencement of services to Client.
- <u>Collection Costs</u>. If Client does not pay IQS an amount due under the terms of this Agreement, and the unpaid amount is referred to a debt collector and/or attorney or attorneys for collection or enforcement, Client agrees to and promises to pay IQS, in addition to the amounts otherwise due, the reasonable costs and expenses of such collection or enforcement, including reasonable attorneys' fees incurred through judicial or collection proceedings and the costs of obtaining any judgment or enforcement order.

## Contract Period: 1 Year and Subsequent Period

If Client elects to extend the Term of this Agreement of one year, and such extension is acceptable to IQS, Client will be invoiced by IQS during the existing Term and timely payment (prior to the expiration of the existing Term) may be tendered by Client to IQS to extend this Agreement and its terms for one or more subsequent period(s) (Subsequent Period). Subsequent period extensions may require increased payments based on inflation and other cost increases experienced by IQS. Each Subsequent Period shall be equal in duration to the Initial Period, unless otherwise agreed to and invoiced by IQS. Contract cannot be canceled in the initial term, and any cancellation after the initial year requires a sixty-day written notice.

## **Entire agreement**

This agreement embodies and sets forth the entire agreement and understanding of the parties and supersedes all prior oral or written agreements, understandings or arrangements relating to the subject matter of this agreement. Neither party shall be entitled to rely on any agreement, understanding or arrangement not expressly set forth in this agreement save for any representation made fraudulently.

IQS may update or amend these Terms of Services, the Acceptable Use Policy, the Privacy Policy, Data Progressing Agreement or the technical specifications of the Services from time to time to comply with the law or meet our changing business requirements. The Customer agrees to review these Terms of Service regularly to ensure they are aware of any changes.
